Qualify as a Solicitor through our Solicitor Apprenticeship programme. Our LLB in Legal Practice degree provides you with the knowledge and opportunity to undertake the Solicitors Regulation Authorities (SRA's) central Qualification Exams.

The five-year degree programme is designed for people who wish to qualify as a solicitor. It is a non-integrated Higher Level Apprenticeship (HLA) pathway, designed to deliver the Solicitor Apprenticeship qualification. The attendance detail is provided as full time this typically includes four days within your chosen law practice with one-day campus or online learning.

If you have not studied law before or only to A-Level standard, then the LLB in Legal Practice is the route for you. The LLB course covers all areas of law required by the SRA in the Foundations of Legal Knowledge. It'll provide you with an opportunity to develop your work-based skills and behaviours – the 'solicitor competencies' – required of a solicitor in legal practice.

For those who already have a degree level, or equivalent, legal education then the Professional Masters - MProf in Legal Practice - is the route to take. The MProf consolidates and builds upon your existing legal knowledge, skills and behaviours and provides an accelerated route to qualification through the Solicitor Apprenticeship.

Overview And Opportunities

This course is for individuals aiming to become a Solicitor. You'll develop your ability to provide legal advice to clients by applying your legal knowledge, skills and commercial judgement to find a solution to problems. The programme operates within the requirements of the SRA's Statement of Solicitor Competence.

You'll develop the full range of legal skills including; research, interviewing and advising, advocacy, negotiation, drafting, communicating orally and in writing, establishing and maintaining effective and professional relationships with clients and managing yourself and your own work effectively.

You'll develop the ability to act ethically with a high level of professionalism and judgement as a Solicitor. You'll have the opportunity to apply critical perspectives on law, policy and behaviour.

Level 4

Compulsory Modules

These modules are set and you have to study these as part of your course.

English Public Law And European Union Law

This module explores primary legislation and discusses the constituent institutions and processes of the English and EU legal systems. You'll also examine the broader legal and political contexts within which they operate.

Contract Law

On this module you'll explore the structure and substantive content of common law and statutory principles that comprise English contract law, using relevant research skills and legal databases. You will apply these principles to hypothetical scenarios and hypotheses to produce persuasive legal arguments and reasoned conclusions.

Tort Law

On this module you'll explore the meaning and legal scope of a range of civil wrongs which comprise tortious liability in English law. This includes examining how and why these torts are created and breached, and with what legal effect, including remedies and limitations.

Work Based Learning 1

This module introduces the principles and processes of self-reflection as they relate to work-based experiences. It also identifies the implications for practice-based skills, knowledge, and behaviours (KSBs) in accordance with the Solicitor Apprenticeship Standard and the SRA's Statement of Solicitor Competence.

Compulsory Modules

Criminal Law

On this module, you'll explore and critically evaluate the concepts of criminal responsibility. You'll do this by looking at specific offences and defences.

Equity And Trusts Law

This module explores the origins, rationale, principles, and operation of natural and positive law sources in English equity and trusts. You'll apply this law to practical scenarios to resolve legal issues effectively.

This module explores the structure and substantive content of common law and statutory principles in English land law. You'll use research skills and legal databases to apply these principles to hypothetical scenarios, producing persuasive legal arguments and reasoned conclusions.

Professional Skills: Synoptic Portfolio

This module focuses on applying critical reflection to work-based experiences. It involves identifying and evaluating the impact on practice-based skills, knowledge, and behaviours in line with the SRA's Threshold Standard for solicitor competence.

Practice And Procedure 2

This module focuses on selecting and applying relevant knowledge, skills, and procedures to meet client needs in specific contexts. It aligns with the Solicitors Regulation Authority's Functioning Legal Knowledge 2 (FLK 2) requirements.

This module focuses on selecting and applying the appropriate knowledge, skills, and procedures to address client needs. It ensures alignment with the Solicitor Regulation Authority's Functioning Legal Knowledge 1 (FLK 1) requirements.

This module involves planning, researching, and producing an independent research project focused on a relevant area of professional legal practice.

Work Based Learning 3

To further develop and deepen the principles and processes of self-reflection to work-based experiences and to evaluate the implications for practice-based skills, knowledge and behaviours (KSB) relative to the Solicitor Apprenticeship Standard and the SRA's Statement of Solicitor Competence.

This module will further develop your self-reflection skills to evaluate work-based experiences. This reflection should focus on how these experiences impact your skills, knowledge, and behaviours (KSB), in line with the Solicitor Apprenticeship Standard and the SRA's competence requirements.

Professional Skills Project

On this module you'll independently plan and carry out a research project that combines your legal knowledge and critical thinking. The project should use research methods to evaluate real-world practice and produce clear, practical outcomes for work-based practice.

Entry Requirements

Tuition Fees are paid by an <u>Apprenticeship Levy</u>, so it's free to you, although you won't qualify for any funding from Student Finance.

We accept learners from a wide range of backgrounds with a key requirement being you must have a willing employer who wishes to put you on the Solicitor Degree Apprenticeship and support you on the course.

There are minimum recommended qualifications but falling below this standard may not prevent you from joining the course.

Please contact us to discuss our entry requirements as your experience in legal practice, a willing employer and a strong desire to succeed through the Solicitor Apprenticeship all play an important role in your application to the course.

- Minimum entry requirements: 3 A2 Levels (or equivalent) whose minimum aggregate total must be 112 points (BBC)
- 5 GCSEs, including Mathematics and English at Grade C/4 or above (or equivalent)
- Relevant employer- led work-based experience which may exempt an apprentice from some training (e.g., Level 3 Advanced Apprenticeship in a relevant occupation; Level 4 Higher Apprenticeship in a relevant occupation)
- Higher legal qualifications which may exempt an apprentice from some training (e.g., a 'qualifying' Law Degree; Graduate Diploma in Law; post-graduate diploma or Masters Degree in Legal Practice)

Information For Employers

An apprentice is employed to do a real job while studying for a formal qualification, usually for one day a week at one of our campuses or training centres.

This course meets Apprenticeship Standards and your apprentice will have the knowledge and skills to either succeed in their chosen career or progress to the next apprenticeship level.

Apprentices follow an approved study programme, which means they'll gain a nationally-recognised qualification at the end of their apprenticeship.

They'll study a broad range of skills and knowledge that can be applied to their professional practice.

Benefits To The Employer

The programme is a great way to address skills and knowledge gaps in your workforce. As well as retain and attract staff who want opportunities for professional development through a high-quality degree.

If your payroll is under £3m, you don't need to pay the Apprenticeship Levy but you can still get funding towards the cost of training and assessment of apprentices. You only pay 5% - the government will co-fund the other 95% (up to the funding band maximum).

If your payroll is over £3m, and you pay the Apprenticeship Levy you can utilise your funding contribution most effectively by signing up members of your own workforce to undertake a solicitor apprenticeship.
